NEW REGISTRATIONS: Please note: Age taken as on the day of competition.

- 1 Registration Form: One form per Competitor must be completed. Complete email address on form if you would like to receive entry forms and updates. Medal & Tiny Tot sections No registration required as this is a NON Status section.
- 2 New Competitor Registration Deadline: New Competitors must be registered BEFORE THE CLOSING DATE OF THE FIRST COMPETITION THEY WISH TO ENTER OR AS IS STIPLUATED ON THE ENTRY FORM FOR "NEW REGISTRATIONS". No Registration forms will be accepted if accompanied by an entry form.
- 3 <u>Juvenile & Juniors</u>: A certified copy of their birth certificate must be attached to the registration form. Failure to do this will result in the dancer not being registered.
- Age Group: Competitors must register in an Age Group based on their age as at date of registration. Dancers must change age groups on the day of their birthday. If moving into a higher age group please state if you wish to be re-graded.

 Dancers must return their number and card to the Status Secretary when changing age groups (a new card fee is payable R20 if both card and number is returned and R50 if either card or number is not returned). If the competition covers more than one day the competitor must dance the age they are on the first day of the competition. Please complete "Change of Status Birthday Anniversary forms"
- 5 <u>Partnership Details</u>: Please give full details of partnerships and advise of any changes well in advance of any competitions. <u>BEFORE</u> <u>THE closing date of competition</u>).
